Article 1 - Parties to the MOU

- 3.3. All costs for registration service, promotion, advertisement, consultancy and organization shall be paid by Parties 2.

Article 4 – The Number of Students

Parties 1 can accept 300 Nigerian Students per Year from Parties 2.

Articles5 - Duration of MOU

The duration of the MOU shall come into force on the date both parties sign the contract and ends on 2021 (3 Years).
