### Article 1 - Parties to the MOU

### Article 3 — Subject of the MOU

3.2. Parties 1 accept Indonesian Students who register through Parties 2.

3.3. All costs for registration service, promotion, advertisement, consultancy and organization shall be paid by Parties 2.

### Article 4 — The Number of Students

Parties 1 can accept 300 Indonesian Students per Year from Parties 2.

### Articles5 — Duration of MOU

The duration of the MOU shall come into force on the date both parties sign the contract and ends on 2021 (3 Years).

### Article 6 — Signature
