Terms of Participation

- •The languages of the paper are Turkish, English and Arabic.
- Papers must not have been previously published or presented at another event.
- Abstract texts should be between 300 and 800 words.
- Participants have the right to present a maximum of 2 papers .
- •The similarity report rate of abstracts should not exceed 15%. Abstracts that do not meet this requirement will be returned to the author without being sent for referee evaluation.
- Abstracts will be subject to double-blind peer review.
- Papers should be prepared according to the paper template and writing rules.
- Abstracts should be sent to the e-mail addresses gsfsanat@atauni.edu.tr or sanattaislamkongresi2025@gmail.com.
- •The congress will be held as a hybrid (online and face-to-face) between 15-17 October 2025.
- Accommodation and transportation are the responsibility of the participants.
- It will not be possible to make changes to the session information after the congress program is determined.
- •In multi-authored studies, only one author can present.
- •The congress is open to everyone who wants to participate, with priority given to those who have
- submitted a paper. Attendance at the congress as a listener is free of charge.
- Participation and Presentation Documents for online presentations will be provided to congress participants in PDF format.
- In order for congress papers to be included in the "Congress Selection Book", the congress registration process must be completed, the paper must be presented at the congress and the selection committee must approve it.
- The congress evaluation process is international in terms of scientific board structure and participant diversity and meets the academic promotion criteria of the relevant institutions according to the 2025 criteria.
